

## LORAIN COUNTY DOMESTIC RELATIONS COURT ZOOM INFORMATION

Domestic Relations Court and Juvenile Court cases may be held virtually via Zoom or in person at the Lorain County Justice Center, 225 Court Street, Elyria, OH 44035. **You will receive notice and/or a Court Order with a hearing date and the physical location of your Court hearing.** Many of the hearings at the Justice Center and Detention Home are held virtually, via Zoom. Mandatory in-person appearance will be written on the notice and/or Court Order. **If you have questions and/or want to confirm if you can appear by Zoom, please contact: (440) 329-5369 or the General Information phone number for the assigned Judge.**

The Domestic Relations Court has three Judges and eleven Magistrates that conduct hearings at the Justice Center. One Intake Magistrate is located at the Lorain County Detention Home, 9967 S. Murray Ridge Rd., Elyria, OH 44035. Detention hearings are scheduled for the next business day but no later than 72 hours after a juvenile is detained.
